

- Applies to creating new businesses
- Applies to developing an existing business

## BUSINESS TALENT (PERMANENT) VISA (SUBCLASS 132)

- **Significant Business History**

- 2 out of last 4 years before applying
  - Doing Business in Australia
  - Annual business Turnover AUD 3 million
  - Net business & personal asset
  - AUD 1.5 million
  - AUD 400,000 business equity OR
  - 10% shareholding of issued capital (public listed companies) For services, detail the terms and conditions under which the service is offered

- **Venture Capital Entrepreneur**

- must have sourced venture capital funding from a member of AVCAL (Australian Venture Capital Association Limited)- No Age and No English requirements
- at least AUD 1 million in venture capital funding to start commercialisation & development of a high value business idea in Australia

---

## BUSINESS INNOVATION & INVESTMENT (PROVISIONAL) VISA (SUBCLASS 188)

- **Business Innovation**

- Establish, Develop & Manage new/existing business in Australia
  - points tested - 65 points
  - be under 55 years or exempt
  - total business turnover AUD 500,000 p.a. (2 of 4 years)
  - AUD 800,000 net assets for transfer to Australia within 2 years of visa
  - No English requirement

- **Investor (IV)**

- make Designated Investment of at least AUD 1.5million in an Australian state/territory & maintain business/investment activity
  - points tested - 65 points
  - 3 years business experience
  - be under 55 years or exempt
  - Designated investment of 1.5 million into treasury bonds
  - Net business and personal assets of 2.25 million



---

## BUSINESS INNOVATION & INVESTMENT (PROVISIONAL) VISA (SUBCLASS 188)...CONTINUES

- **Significant Investor stream (SIV)**

- make and hold Complying Investment of at least AUD 5 million for a minimum of 4 years
  - diversified investment (Government bonds, managed funds, direct investment into private Australian companies)
  - no points test
  - no age barrier
  - flexible residence requirement

- **Premium Investor stream (PIV)**

- make and hold Complying Investment of at least AUD 15 million for a minimum of 4 years
  - nomination and Investment by Austrade
  - apply for Permanent residency after 12 months of maintaining investment
  - no age barrier
  - no points test
  - no residence requirement (for applicant and dependants)

## NEW ZEALAND INVESTOR PLUS (CATEGORY 1) AND INVESTOR VISA (CATEGORY 2)


Key requirements	Investor Plus (Investor 1 Category)	Investor (Investor 2 Category)
Maximum age	No requirement	65 or younger
Business experience	No requirement	Minimum of three years
Investment funds	NZ\$10 million invested in NZ for three years	NZ\$1.5 million invested in NZ for four years
Settlement funds	No requirement	NZ\$1 million (transfer not required)
Minimum time in New Zealand	73 days in NZ in each of the last two years of the three-year investment period	146 days in NZ in each of the last three years of the four-year investment period
