> General Skilled Migration (GSM) Visas (sc 189, 190, 491)

> > Employer Sponsored Visas (sc 482, <mark>186</mark>)

> > > National Innovation Visa (sc 858)

Assumptions about you



- A student visa holder under the age of 35 studying a Bachelor or Masters Degree (Coursework).
- A student visa holder under the age of 50 studying a Masters (Research) or a Doctoral Degree.
- Graduate Diploma...?
- The course you are enrolled in is registered to run for a min. 2-year duration, and you will complete the course in at least 16 months.



Student > Temporary Graduate Visa (sc 485)

What is the 485 visa?

- A temporary visa that allows international graduates to spend time in Australia post-completion of a relevant course.
- May be initially valid for 2-5 years, depending on the course studied and visa applicant's passport.

Why the 485 visa?

- Upcoming student visa expiry
- Full work rights
 - The time you need to gain work experience and become eligible for a skills assessment/employer sponsored visa.
 - Work experience is worth points on the points test for GSM visas.



Which 485 visa?

- First-timers: Two streams Post-Higher Education Work stream and Post-Vocational Education Work stream
 - Post-Higher Education If you have attained a bachelor degree, masters degree (coursework or research), graduate diploma, or a PhD.
- Regional extension:
 - For post-higher education stream 485 visa holders only.
 - Graduated from a regional institution.
 - Have continued to reside (including all work and study) for at least two years in a regional area.



Location	Definition	Incentive
Major City	Melbourne, Sydney, Brisbane	None
Cities and major regional centres	Perth, Adelaide, Gold Coast Sunshine Coast, Canberra, Newcastle, Lake Macquarie, Wollongong, Illawarra, Geelong, Hobart	Eligible to access an additional 1 year in Australia on a post-study work visa.
Regional centres and other regional areas	All other locations	Eligible to access an additional 2 years in Australia on a post-study work visa.



485 visa essentials

- Lodge visa application <u>after</u> and within 6 months of course completion date.
- Lodge visa application while onshore (physically in Australia).
 - Lodge visa application <u>prior</u> to student visa expiry (ideal).
- Apply for AFP clearance <u>prior</u> to lodgement of visa application.
- Sit for English language test no more than 12 months <u>prior</u> to lodgement of visa application (UK, USA, Ireland, Canada, NZ citizens exempt).



Most applicants:

IELTS	Overall score of at least 6.5 with a minimum score of 5.5 for each of the 4 parts
TOEFL (only if taken after 4 May 2024)	Total score of at least 83 with a minimum score of 7 for listening, 8 for reading, 18 for writing and 16 for speaking.
PTE	Overall score of at least 57 with a minimum score of 43 for listening, 48 for reading, 42 for speaking and 51 for writing.
OET	At least B for each of the 4 parts
Cambridge Advanced English	Overall at least 176 with a minimum score of at least 162 in each of the 4 test components



Holders of British National (BNO) or Hong Kong passports:

IELTS	Overall score of at least 6 with a minimum score of 5 for each of the 4 parts
TOEFL (only if taken after 4 May 2024)	Total score of at least 83 with a minimum score of 4 for listening, 4 for reading, 14 for writing and 14 for speaking.
PTE	Overall score of at least 50 with a minimum score of 36 for each of the 4 parts.
OET	At least B for each of the 4 parts
Cambridge Advanced English	Overall at least 169 with a minimum score of at least 154 in each of the 4 test components

Employer Sponsored Visas (482, 186) 482

- ☐ Have at least 1 year of full-time work experience in your nominated occupation or a related field
- ☐ Nominated by an employer in a skilled occupation
- ☐ No age limit, no points test
- ☐ Visa can be valid from 1-4 years
- ☐ Must only work in your nominated occupation





Employer Sponsored Visas (482, 186)

186 – Direct Entry

- Nominated by an employer in a skilled occupation
- ☐ Successful skills assessment result
- ☐ Competent English
- No points test
- ☐ Have worked at least 3 years fulltime in your nominated occupation (working with any employer, in or outside of Australia)
- ☐ Age limit of 45 years of age

186 – Temporary Residence Transition

- Nominated by an employer in a skilled occupation
- ☐ Competent English
- No points test
- ☐ Have worked at least 2 years in Australia on a 482 visa
- ☐ Age limit of 45 years of age. But there are exemptions
 - ☐ Fairwork High Income Threshold exemption



National Innovation Visa

- ☐ Have an internationally recognised record of exceptional and outstanding achievement in one of the following areas:
 - a profession
 - a sport
 - the arts
 - academia and research
- ☐ Have a nominator with a national reputation in your area of talent who is:
 - an Australian citizen,
 - an Australian permanent resident, or
 - an Australian organisation






Global Talent Visa - Process

- ☐ By Invitation
 - o Priority ranking

Priority one	Exceptional candidates from any sector who are global experts and recipients of international 'top of field' level awards.
Priority two	Candidates from any sector nominated on the approved Form 1000 by an expert Australian Commonwealth, State or Territory Government agency.
Priority three	Candidates with exceptional and outstanding achievements in a Tier One sector: Critical Technologies Health Industries Renewables and low emission technologies
Priority four	Candidates with exceptional and outstanding achievements in a Tier Two sector: Agri-food and AgTech Defence Capabilities and Space Education Financial Services and FinTech Infrastructure and Transport Resources
